#### The context

Grand narrative criminology - broad shifts in penal culture and practice

• '... risks elevating an explanatory framework largely informed by the specificities of the US situation to the status of a general theory of penal dynamics' (Lacey 2008: 26)

Political-economy, national cultures and penal policy:

e.g. Cavadino and Dignan (2006); Lacey (2008); Pratt (2008a, 2008b)

Levels of severity/tolerance generally measured through prison population rates, prison 'conditions', official sources, etc (although see Pratt and Eriksson 2013)

#### Limitations

- Imprisonment rates = quantity rather than 'texture' of imprisonment
- Official aims & rhetoric Vs 'on the ground' experience
- The prisoner experience is relational, as much as material
- Inputs Vs outcomes
- Harsh/tolerant for whom, in what ways? In which parts of the system?
  - see Barker (2012) on 'the paradox of a Janus-faced penal regime', Ugelvik and Dullum (2011), Scharff-Smith and Ugelvik (2017)

#### Research questions


- What do 'inclusionary' (or 'social-democratic') and 'exclusionary' (or 'neo-liberal') punishment systems look like in practice?
- o How are they experienced?

- (1) a test of the NE thesis
- (2) an attempt to conceptualise the nature of imprisonment

#### Sensitising concepts

- Depth (see Downes 1988): distance & difference from outside world e.g. security, control, permeability
- Weight (see King and McDermott 1988; Liebling and Arnold 2004):
   oppressiveness, burden & use of authority, interpersonal treatment
- Tightness (Crewe 2009, 2011): invasiveness, grip, impact on personal identity & self-regulation
- o Breadth: reach & impact beyond the prison e.g. stigma, 'disabilities', etc.
- Penal consciousness
- Shame / guilt

#### Aims


- A contribution to the revival of prison ethnography
- o 'Gendering' the field
- Development of vocabulary & framework for comparing penal cultures
- Concrete analysis of the dynamics of the penal state, in different jurisdictions, and the relationship between penal politics and prisoner experiences
- Interrogation of the foundational labels and theories of comparative penology
- Description and 'explanation' of differences in penal regimes and experiences
